What is the NICS Improvement Amendments Act of 2007? The NICS Improvement Amendments Act of 2007 (NIAA), Pub. L. 110-180, was signed into law by the President on January 8, 2008. The NIAA amends the Brady Handgun Violence Prevention Act of 1993 ("the Brady Act") (Pub. L. 103-159), under which the Attorney General established the National Instant Criminal Background Check System (NICS).
