Set up a business partnership: Register the partnership ...

Sign in or register for your personal or business tax account, Self Assessment, Corporation Tax, PAYE for employers, VAT and other services

HMRC services: sign in or register - GOV.UK

Registered business name, trading name or individual (You need to enter at least two characters.)
or

HM Revenue & Customs - Supervised Businesses Register

Registering with HMRC. Companies House automatically notifies HMRC when a limited company or limited liability partnership is incorporated. Soon after your business has been set up, you should receive a letter from HMRC at your registered office address advising you of your tax obligations and requirements.
